The conference theme is 'Driving toward sustainability with Eco-transportation'. The research would focus on discussing technological options, new materials, suitable policy, to solve transportation problem in developing countries as well as promote sustainability through Eco-transportation concept.

The abstract must be written in English and should be headed by a **title**, **name(s)** and **complete** address(es) of the author(s). Please <u>underline the name</u> of the author who will present the paper and leave a 3.0 cm margin on top and 2.5 cm margin on all other side. The abstract can contain Figures, Table and References, but the length of the abstract should not exceed one A4 page with 600 words maximum and the main text should be written in 12 point Time New Roman font. Format of paragraph: spacing before 3pt and after 3pt, single line spacing, and none indentation for the first line.

If there is any figures, tables or equation to be referenced in the text, it should be clear and legible and should follow a uniform style throughout.

The abstract should be submitted in DOC or PDF format through the online abstract submission system by 15th May 2018.




Figure 1. The figure caption, in 10 point, italic and should be centred immediately below the figure.
